
City of Yokohama Adjusted Benefit

Benefit for Persons Projected to Not Fully Covered by the Flat-amount Cut of Personal Income Tax

In regards to the flat-amount cut to be applied to income tax and personal residence tax levy for FY2024, the City of Yokohama will pay an amount rounded up to the nearest 10,000 yen for the amount not covered by the flat-amount cut to persons projected to be not fully covered the flat-amount cut for personal income tax (the allowed flat-amount cut exceeds your estimated income tax amount*1 for FY2024 or your personal resident tax levy amount for FY2024).

*1: Amount estimated based on income amount, etc. used to estimate the personal resident tax as of June 3.



Application method and payment period

A "Notification of Benefit Payment" or "Confirmation Letter" will be sent to eligible persons gradually beginning from July 22, 2024.

- 1) Persons with an account for receiving public benefits registered through the My Number Portal, etc.**2
 - Notification of Benefit Payment (no procedures required)

Payment will be made in order to registered accounts beginning from August 19, 2024 (Mon.) *2: Even if you have a registered account for receiving public benefits, instead of ① receiving a Notification of Benefit Payment, you may be subject to ② receiving a Confirmation Letter on which you will be asked to provide your bank account and other required information.

- 2 Persons without an account for receiving public benefits
 - Confirmation letter procedure required

On the Confirmation Letter, provide your bank account and other required information, then return via postal mail.

Payments will be issued once your account is confirmed.

Application period: July 24 (Wed.) to October 25 (Fri.), 2024 must arrive by

If you are eligible to receive this benefit but do not receive a "Notification of Benefit Payment" or "Confirmation Letter", or if you wish to request reissuance, then please contact the "City of Yokohama Call Center for Emergency Benefit Payment Due to Rising Prices of Electricity, Gas, Food, etc." indicated on the reverse side of this document by October 18, 2024 (Fri.).

Points of Attention

If the Flat-amount Cut Amount is changed and it causes the insufficiency of benefits, then no adjustment will be conducted in FY2024, but the city plans to issue a benefit to cover any insufficient amount during FY2025. Details will be provided on the City of Yokohama website, etc. as information is received from the government.

Examples of cases resulting in insufficient adjusted benefit amount

- · When there is a change in income or deductions, etc. for FY2023
- When the flat-amount cut cannot be made based on the income tax amount and personal resident tax levy amount after applying a housing loan deduction and other tax deductions
- When your family gave birth to a child during FY2024 resulting in an increase in dependent family members
